Dear Parents,

Greetings from Smart Wonders!

As we have come to the end of Term 1 of the session 2021-22, I would like to take this opportunity to thank you all for the unwavering faith and support extended during these challenging times. Together we will continue to work for providing engaging and wholesome experiences for our students so that learning continues whether Offline or Online.

As you know we were ready to open school for classes UKG-10 in the Hybrid teaching model (Online and Offline together) from 7th April 2021, however due to the changed circumstances and Government orders we could not. **We have conducted the Assessments for Class 10 in school (Offline) from 1st September 2021 and the students of Classes 9-10 have started their Hybrid Classes (Online and Offline) since 15th September 2021.** The Consent for Offline and Online has been taken from all the classes UKG to Class 10. We are prepared for Hybrid Classes, where both Offline and Online classes are conducted simultaneously and the school is following all the COVID protocols and guidelines issued by the Government. **Based on the situation and Government guidelines we are starting the Hybrid classes for classes 5-8 from 4th October 2021 and for Classes UKG to 4 from 18th October 2021.**

I'm sure all of you are taking all the precautions necessary due to COVID and everyone in your family and friends is safe and healthy. We pray to the Almighty to grace us with good health and happiness. We had a very successful PTM on the 17th and 18th of September for Classes UKG-5 of the Junior Wing and 24th and 25th of September for Classes 6-10 of the Senior Wing. I would like to thank each one of you for your participation and giving your invaluable feedback as we at Smart Wonders School believe that there is always scope for improvement. We consider the parents our partners on this educational journey and always look forward to sharing the progress and accomplishments of our young Wonderites.

The Court has allowed full fee collection for the Academic year 2021-22. However, in the session 2021-22 a discount of Rs. 2000/- in the Annual charges will be given to all the students in the Fee Challan for the Third Quarter as well (October -November- December). This policy will be reviewed at the end of the quarter.

Please make a note of the following points:

1. **FEE:** Kindly deposit the Annual Fee and Tuition Fee for the **Third Quarter i.e. October to December 2021, latest by 20th October 2021**, at Kotak Mahindra Bank, SCF – 108, Phase 3B2, Mohali in the account of **Smart Wonders School, A/c no. 8511228869**. Kindly mention the following details of the child on the reverse of the cheque:

- a) Name of the child
- b) Father's Name
- c) Class, Section & Admission number of the child
- d) Address & Contact Number

2. Last session we had allowed a flexible fee payment schedule to parents and did not impose any late fine. However, this session late fee charges of Rs. 50/- per day will be applicable from 21st October 2021 onwards.
3. The Fee Challan has been attached with this circular. Where applicable, the pending amount of the first / second quarter has been added in the Fee Challan.
4. There shall be a special discount of Rs 2000/- in the Annual Charges for all the students in the Fee Challan for the Third Quarter only. (October -November- December).

NEFT transactions shall also be allowed, however the parents need to submit the details of the student i.e. **Name of the Child, Father's Name, Class with Section, Admission number, UTR/Reference Number and details of the Account Holder from whose NEFT is done** by mail to the school or share screenshot at 9914815444 / 9888315301. In case the information is not provided, the fee deposited shall be treated as **NOT PAID**.
